**Product description :** Sea-Line® C2 CONCENTRATE CLEANER very powerful water soluble and biodegradable cleaner for quick and efficient removal of dirt, oil, grease, scale, soot, nicotine etc. Great as a professional cleaner for fenders, tarpaulins, poles and aluminum ship components and for the removal of hydraulic oil



**Recommended use:** Sea-Line® C2 can be use for cleaning surfaces :

- GRP laminatem.
- painted surfaces.
- aluminum.
- PCV (pontons).
- rubber (reflectors, plastic strips, gaskets).
- textiles (tents, covers, tarpaulins).

**NOTE :** Do not use on glass (for example mirrors) and materials made of natural leather.

### Physiochemical Characteristics:

**Appearance:** liquid  
**Color:** red (transparent)  
**Smell:** specific  
**Solubility in water:** 100%

**Preparing the surface:** Wash the work surface other contaminations (for example sand) with fresh water.

**Method of application:** Microfiber or other soft cloth, soft brush.

- Application :**
- Thin Sea-Line® C2 with water (can be diluted with hot and cold water):
    - 1:10 for normal dirt (add 1 part of C2 on 10 parts of water).
    - 1:5 for heavy dirt (add 1 part C2 on 5 parts of water).
  - Wash surface the cloth or soft brush.
    - On very dirty surfaces leave C2 for few minutes then clean with soft brush.
  - After treatment, always rinse with plenty of water.
  - Using microfiber cloth wipe the surface till is dry.

**Further Work :** To protect the surface use :

- S4 Protect wax
- S5 Quick wax

- General Cautions :**
- Please follow safety instructions from the technical data sheet and follow workplace safety laws.
  - Avoid contact with skin and eyes.
  - When using the product in a small, enclosed space you must use forced ventilation.
  - It is also recommended that you protect your respiratory system, eyes, and skin.

### Storage :
